TO: Board Secretary of Joplin Schools or designee

I, the undersigned, a resident of the Joplin Schools District, declare myself a candidate for the office of a director of said school district for a term of **three (3) years**, to be voted on at the municipal election to be held on the 2nd day of April, 2024.

I declare that I am eligible to hold office in accordance with Missouri law. I:

- 1. Am a citizen of the United States of America. Mo. Const. art. VII, § 8; § 162.291, RSMo
- 2. Am a resident taxpayer of the Joplin School District. § 162.291, RSMo.
- 3. Will have resided in the district and Missouri for a minimum of one (1) year immediately preceding my election, if elected.

- 4. Am at least 24 years of age. § 162.291m RSMo.
- Am not delinquent in the payment of any state income taxes, personal property taxes, municipal taxes or real property taxes on my place of residence listed below. If I am a past or present corporate officer of any fee office, I verify that office does not owe any taxes to the state. I understand that I am required by law to file an affidavit stating these facts with the Missouri Department of Revenue. § 115.306, RSMo.
- 6. Have not been found guilty of nor have I pled guilty to a felony under the federal laws of the United States of America or to a felony under Missouri law or an offense committed in another state that would be considered a felony in Missouri. § 115.306, RSMo.
- 7. Am not registered or required to be registered as a sex offender pursuant to Missouri law, § 162.014, RSMo.
- 8. Have filed, or the treasurer of any existing candidate committee has filed, all required campaign disclosure reports with the Missouri Ethics Commission, when applicable, for all previous elections in which I was a candidate. § 130.071, RSMo.
